YOU ARE HEREBY NOTIFIED that the State Finance Committee of the State of Washington (the "Committee"), acting by and through the State Treasurer, online via Zoom, and by telephone as detailed below, commencing at approximately 12:00 P.M., on the 26th day of April, 2022, will consider for approval the following proposed Bond Sale Resolutions and minutes:

1. Approval of minutes of the February 8, 2022 meeting.
2. Resolution No. 1258 awards the sale of \$856,295,000, more or less, of State of Washington Various Purpose General Obligation Refunding Bonds, Series R-2022C, as authorized by Resolution No. 1249 of the Committee, and Chapters 39.42 and 39.53 RCW.
3. Resolution No. 1259 awards the sale of \$496,565,000, more or less, of State of Washington Motor Vehicle Fuel Tax General Obligation Refunding Bonds, Series R-2022D, as authorized by Resolution No. 1249 of the Committee, and Chapters 39.42 and 39.53 RCW.
4. Public Comments.

The results of the foregoing bond sales will be posted on the State Treasurer's website promptly following approval of the Bond Sale Resolutions by the State Treasurer on behalf of the Committee.

Per Governor Inslee's Proclamation 20-28 (as amended and extended) regarding the Open Public Meetings Act, the April 26, 2022 adoption of Bond Sale Resolutions will be held remotely through a secure online option, using Zoom, with a dial-in option for telephone participation, as described below.
