YOU ARE HEREBY NOTIFIED that the State Finance Committee of the State of Washington (the "Committee"), acting by and through the State Treasurer, online via Zoom, with public participation via Zoom, telephonically, and in-person at the Helen Sommers Building, Conference Room 1015, Olympia, as detailed below, commencing at approximately 11:30 A.M., on the 19<sup>th</sup> day of July, 2022, will consider for approval the following proposed Bond Sale Resolutions and minutes:

1. Minutes. Approval of minutes of the June 14, 2022 meeting. Approval of amendments to the minutes of the November 2, 2021 meeting. Approval of amendments to the minutes of the April 26, 2022 meeting.
2. Resolution No. 1264 awards the sale of \$707,500,000, more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2023A, as authorized by Resolution No. 1247 of the Committee; Chapter 167, Laws of 2006; Chapter 414, Laws of 2019; Chapter 331, Laws of 2021; and Chapter 39.42 RCW.
3. Resolution No. 1265 awards the sale of \$140,130,000, more or less, of State of Washington General Obligation Bonds, Series 2023T (Taxable), as authorized by Resolution No. 1247 of the Committee; Chapter 414, Laws of 2019; Chapter 331, Laws of 2021; and Chapter 39.42 RCW.

The results of the foregoing bond sales will be posted on the State Treasurer's website promptly following approval of the Bond Sale Resolutions by the State Treasurer on behalf of the Committee.
