YOU ARE HEREBY NOTIFIED that the State Finance Committee of the State of Washington (the "Committee"), acting by and through the State Treasurer, online via Zoom, with public participation via Zoom, telephonically, and in-person at the Office of the State Treasurer, Legislative Building, Second Floor, Room 230, Olympia, Washington, as detailed below, commencing at approximately 12:00 P.M., on the 25th day of July, 2023, will consider for approval the following proposed Bond Sale Resolutions and minutes:

1. Minutes. Approval of minutes of the April 26, 2023, meeting.
2. Resolution No. 1275 awards the sale of \$692,245,000, more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2024A, as authorized by Resolution No. 1271 of the Committee; Chapter 3, Laws of 2018; Chapter 414, Laws of 2019; Chapter 331, Laws of 2021; Chapter 473, Laws of 2023; and Chapter 39.42 RCW.
3. Resolution No. 1276 awards the sale of \$381,580,000, more or less, of State of Washington Motor Vehicle Fuel Tax and Vehicle Related Fees General Obligation Bonds, Series 2024B, as authorized by Resolution No. 1272 of the Committee; Chapter 431, Laws of 1993 (RCW 47.10.812); Chapter 315, Laws of 2005 (RCW 47.10.873); Chapter 45, Laws of 2015, 3rd Sp. Sess. (RCW 47.10.889-.895); and Chapter 39.42 RCW.
4. Resolution No. 1277 awards the sale of \$55,220,000, more or less, of State of Washington General Obligation Bonds, Series 2024T (Taxable), as authorized by Resolution No. 1271 of the Committee; Chapter 414, Laws of 2019; Chapter 331, Laws of 2021; Chapter 473, Laws of 2023; and Chapter 39.42 RCW.
