3. Resolution No. 1279 awards the sale of \$186,225,000, more or less, of State of Washington Motor Vehicle Fuel Tax and Vehicle Related Fees General Obligation Refunding Bonds, Series R-2024B, as authorized by Resolution No. 1273 of the Committee, and Chapters 39.42 and 39.53 RCW.
