Chair Pellicciotti called the meeting to order at 12:04 PM. Chair Pellicciotti stated the purpose of the meeting to be the approval of minutes from a prior meeting and the adoption of three Bond Sale Resolutions.

- 1. Chair Pellicciotti introduced draft minutes from the April 26, 2023, Adoption of Bond Sale Resolutions meeting. No corrections or amendments were requested. Chair Pellicciotti approved the minutes as presented.

Next, Secretary Richter provided an overview of the bond sales, the state’s municipal advisors provided comments on market conditions, and Chair Pellicciotti adopted the following Bond Sale Resolutions:

- 2. **Resolution No. 1275** awarding the sale of \$682,590,000 of State of Washington Various Purpose General Obligation Bonds, Series 2024A, as authorized by Resolution No. 1271 of the Committee; Chapter 3, Laws of 2018; Chapter 414, Laws of 2019; Chapter 331, Laws of 2021; Chapter 473, Laws of 2023; and Chapter 39.42 RCW.
- 3. **Resolution No. 1276** awarding the sale of \$376,615,000 of State of Washington Motor Vehicle Fuel Tax and Vehicle Related Fees General Obligation Bonds, Series 2024B, as authorized by Resolution No. 1272 of the Committee; Chapter 431, Laws of 1993 (RCW 47.10.812); Chapter 315, Laws of 2005 (RCW 47.10.873); Chapter 45, Laws of 2015, 3<sup>rd</sup> Sp. Sess. (RCW 47.10.889-.895); and Chapter 39.42 RCW.

4. **Resolution No. 1277** awarding the sale of \$55,105,000 of State of Washington General Obligation Bonds, Series 2024T (Taxable), as authorized by Resolution No. 1271 of the Committee; Chapter 414, Laws of 2019; Chapter 331, Laws of 2021; Chapter 473, Laws of 2023; and Chapter 39.42 RCW.
5. Chair Pellicciotti opened the meeting to public comment: No members of the public provided comment.
