YOU ARE HEREBY NOTIFIED that the State Finance Committee of the State of Washington (the "Committee"), acting by and through the State Treasurer, online via Zoom, with public participation via Zoom, telephonically, and in-person at the Office of the State Treasurer, Legislative Building, Second Floor, Room 230, Olympia, Washington, as detailed below, commencing at approximately 12:00 P.M., on the 25th day of June, 2024 will consider for approval the following minutes and proposed Bond Sale Resolutions:

Resolution No. 1284 awards the sale of \$829,935,000, more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2025A, pursuant to Chapter 39.42 RCW; Chapter 3, Laws of 2018; Chapter 414, Laws of 2019; Chapter 331, Laws of 2021; Chapter 473, Laws of 2023; and Resolution No. 1271 of the Committee.

Resolution No. 1285 awards the sale of \$208,390,000, more or less, of State of Washington Motor Vehicle Fuel Tax and Vehicle Related Fees General Obligation Bonds, Series 2025B, pursuant to Chapter 39.42 RCW; Chapter 431, Laws of 1993; Chapter 45, Laws of 2015, 3rd Sp. Sess.; and Resolution No. 1272 of the Committee.
4. Resolution No. 1286 awards the sale of \$45,180,000, more or less, of State of Washington General Obligation Bonds, Series 2025T (Taxable), pursuant to Chapter 39.42 RCW; Chapter 414, Laws of 2019; Chapter 331, Laws of 2021; and Resolution No. 1271 of the Committee.
5. Resolution No. 1287 awards the sale of \$286,580,000, more or less, of State of Washington Various Purpose General Obligation Refunding Bonds, Series R-2025A, pursuant to Chapters 39.42 and 39.53 RCW, and Resolution No. 1273 of the Committee.
