V. Public Deposit Protection Commission Overview Update

- Administrator Mandy Kaplan updated members on the public deposit protection program.
- As of December 2024, our state and local governments had over \$11 billion dollars on deposit in public depositary banks and credit unions.
- Of the 76 current public depositaries, 75 of 76 are "Well Capitalized" by federal standards.
- The one depositary classified as "Adequately Capitalized" was required to increase and maintain to one hundred percent collateral. They meet the collateral requirements in accordance with Washington Administrative Code requirements.
- Public depositary conditions and pledged collateral are sufficient to ensure the safety of state and local government deposits.

Having no further business before the Public Deposit Protection Commission, Chair Pellicciotti adjourned the meeting at 2:10 PM.
