YOU ARE HEREBY NOTIFIED that the State Finance Committee of the State of Washington (the "Committee"), acting by and through the State Treasurer, at the Office of the State Treasurer, Legislative Building, Second Floor, Room 230, Olympia, commencing at approximately 11:00 A.M., on the 28th day of June, 2016, will consider for approval the following proposed Bond Sale Resolutions:

1. Resolution No. 1184 awards the sale of \$392,265,000, more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2017A, as authorized by Resolution No. 1170 of the Committee, Chapter 167, Laws of 2006; Chapter 498, Laws of 2009; Chapter 20, Laws of 2013, 2nd Sp. Sess.; Chapter 37, Laws of 2015, 3rd Sp. Sess.; and Chapter 39.42 RCW.
2. Resolution No. 1185 awards the sale of \$101,345,000, more or less, of State of Washington General Obligation Bonds, Series 2017T (Taxable), as authorized by Resolution No. 1170 of the Committee, Chapter 167, Laws of 2006; Chapter 20, Laws of 2013, 2nd Sp. Sess.; Chapter 37, Laws of 2015, 3rd Sp. Sess.; and Chapter 39.42 RCW.
3. Resolution No. 1186 awards the sale of \$535,125,000, more or less, of State of Washington Various Purpose General Obligation Refunding Bonds, Series R-2017A, as authorized by Resolution No. 1172 of the Committee, and Chapters 39.42 and 39.53 RCW.
4. Resolution No. 1187 awards the sale of \$272,470,000, more or less, of State of Washington Motor Vehicle Fuel Tax General Obligation Refunding Bonds, Series R-2017B, as authorized by Resolution No. 1172 of the Committee, and Chapters 39.42 and 39.53 RCW.

The results of the foregoing bond sales will be posted on the State Treasurer's website promptly following approval of the Bond Sale Resolutions by the State Treasurer on behalf of the Committee.
