Resolution No. 1155 awards the sale of \$207,015,000 more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2015A-1, as authorized by Resolution No. 1148 of the Committee, Chapter 167, Laws of 2006; Chapter 49, Laws of 2011, 1st Sp. Sess.; Chapter 1, Laws of 2012, 2nd Sp. Sess.; Chapter 20, Laws of 2013, 2nd Sp. Sess.; and Chapter 39.42 RCW.
2. Resolution No. 1156 awards the sale of \$22,580,000, of State of Washington Various Purpose General Obligation Bonds, Series 2015A-2, as authorized by Resolution No. 1148 of the Committee, Chapter 167, Laws of 2006; Chapter 49, Laws of 2011, 1st Sp. Sess.; Chapter 1, Laws of 2012, 2nd Sp. Sess.; Chapter 20, Laws of 2013, 2nd Sp. Sess.; and Chapter 39.42 RCW.
3. Resolution No. 1157 awards the sale of \$85,930,000, more or less, of State of Washington General Obligation Bonds, Series 2015T (Taxable), as authorized by Resolution No. 1148 of the Committee, Chapter 20, Laws of 2013, 2nd Sp. Sess.; and Chapter 39.42 RCW.
4. Resolution No. 1158 awards the sale of \$418,975,000, more or less, of State of Washington Various Purpose General Obligation Refunding Bonds, Series R-2015A, as authorized by Resolution No. 1150 of the Committee, and Chapters 39.42 and 39.53 RCW.
5. Resolution No. 1159 awards the sale of \$420,235,000, more or less, of State of Washington Motor Vehicle Fuel Tax General Obligation Refunding Bonds, Series R-2015B, as authorized by Resolution No. 1150 of the Committee, and Chapters 39.42 and 39.53 RCW.
